ADMINISTRATION REPORT – Trish Burns

<u>Update on Pinconning Building</u> – T. Burns spoke with AKT Peerless last week and understands once they receive approval, they will conduct an investigation at the site, which enables them to spec out a dig. Bids for the excavation will be issued publicly and once they are received, it is expected digging will take place this fall.

<u>Sage gables done</u> – The Sage gable repair has been completed. The gables will be painted in late fall.

<u>Tall Ships</u> – The library had a tent in the park during all three days of the Tall Ships Festival. Performers included storytellers and musicians with a nautical theme. The Friends of the Bay County Library System generously sponsor this festival event. It is estimated over 1,700 people stopped by.

<u>Linwood Lot</u> – A survey has been completed on the library owned lot in Linwood where the Bookmobile stops each month. Library staff can now make repairs without fear of encroaching onto the adjoining property.

<u>Book Sale</u> – The Friends Annual Book Sale will be held August 1-3 at the Civic Arena. The funds the Friends make during this sale come back to the library in the form of programs, materials, furniture, special collections, and many other items.
