FINANCIAL REPORT

<u>August 2019 Financial Report, and Penal Fine Report</u> – Kevin Ayala reported penal fines came in at \$30,725 for August, bringing the year to date total received to \$223,978, nearly \$16,000 over the budgeted amount. The total revenues received for last month came in at \$103,000, which included penal fines, Friends' booksale and the property in lieu of taxes. Expenses are on budget.

ADMINISTRATION REPORT – Trish Burns

<u>Community Outreach</u> – The Bay County Library participated in the first annual Chicken Wing Eating Contest for the United Way of Bay County. A five member library team went head to head with 12 other teams for five rounds of eating. The library's team, The Wingmen, did not win, but through team effort, did not come in last.

<u>Downtown Fall Days</u> – The library also participated in the Downtown Management Board's Fall into Downtown weekend along with dozens of other businesses. Held on the second Sunday in September, the staff welcomed visitors with friendly service and the Promotion Commotion Library Card discount program.

<u>Statewide award</u> – Dani, DiAmico, Children's Department Head for the Sage Branch Library, has been awarded the Rising Star Award, by the Michigan Library Association. The Rising Star Award is given to a library employee who has been in the field for less than five years and has, among other attributes, helped establish a library culture that sets high standards, promotes learning, and makes the library an integral part of the community. The award will be given at the MLA Annual Conference in Novi on October 17. The MLA offices will be sending press releases to local news outlets.

<u>Narcan</u> – Governor Whitmer signed the Narcan bill package into law in July, with immediate effect. These bills will provide liability protection for libraries when providing the life-saving opioid antidote naloxone, common brand name Narcan, to an overdosing patron. The library will work to procure both Narcan and training for staff, as well as written guidelines for staff.

<u>New website</u> – T. Burns gave a brief demonstration of the library's new website, pointing out several of its features.
